Annual Meeting: January 25, 2015

Opening

Everyone enjoyed a hot dog lunch. The annual meeting was called to order at 12:04 p.m., by Pastor Becky Robbins-Penniman, who opened with prayer.

Decisions

- Jan Cote was appointed clerk for the meeting.
- Cheryl Sharpe moved to accept the minutes from January 26, 2014 as submitted, Carol Carlson seconded. All were in favor and the motion passed.
- Vestry Elections. The slate of Vestry candidates was presented by Judy Warner: Chris Schombs [3 yr. term], Maureen Belote [3 yr. term], Cheryl Sharpe [3 yr. term].
Jane Morris moved to close the nominations. Michelle Schombs seconded. Motion passed.
Shirl Ahrens moved to approve the slate of candidates as presented. Jane Morris seconded. Motion passed.
- Endowment Board Elections. The slate of candidates was presented by Shirl Ahrens: Carolyn Hughes [3 yr. term], Shirl Ahrens [3 yr. term].
Vote by acclamation. Motion passed.

Recognitions

- Pastor Becky reviewed the lengthy list of volunteer opportunities at Good Shepherd [p. 12 of the 2014 Annual Report.] She offered her heartfelt thanks to all who serve in these ministries.
- Judy Warner and Dan Smith offered their thanks to the current Vestry members and presented a gift to Jane Morris, the only Vestry member retiring.
- Pastor Becky introduced the staff members and thanked them for their service. [Bob Shone, organist; Jan Cote, parish administrator; Cindy Roehl, diaconal intern; Garry Lumm, sexton; and Marcia Nauman, bookkeeper]
- Pastor Becky introduced members who joined during 2014 and read the names of those who died during 2014, then paused for a moment of prayerful thanksgiving.
- Judy Warner, on behalf of the congregation, offered heartfelt thanks to Pastor Becky and Gus for their ministry here.

Reports

- Dan Smith reported on Capital Improvements. The Capital improvements started with replacing the church siding in 2013. The generous gifts from the Capital Campaign made our other projects possible. The Top Priority and High priority projects are almost completed! The metal roof on the sanctuary will be finished by February; the renovation of the

six bathrooms will begin shortly. If funds allow, we will tackle the "Grand Canyon" in the parking lot. Your gifts are most welcome!

- Pastor Becky thanked Dan Smith and Judy Warner for their service as Wardens.
- Scott Hood reviewed the 2014 final report. He pointed out:
 - Contributions were over budget; expenses were under budget.
 - Endowment Distribution was 6.3%, rather than the 5% we hoped for.
 - Our budgeted deficit of \$57,000 in 2014 was offset by \$37,000.
 Looking at our 2015 Budget, Scott made these observations:
 - We are anticipating an 8.5% increase in contributions.
 - The Diocesan Tithe in the budget does NOT include the tithe from the Capital Campaign. That will come from campaign contributions.
 - The staff had an increase of 5.8%.
 - \$2,000 was budgeted for Outreach, but much more is given through the Thrift Shops, Rector's Fund, and various fundraisers and in-kind donations..
 - Once again we have a deficit budget, trying to hold to an Endowment Distribution of 5%.
- Shirl Ahrens introduced the 2014 Endowment Fund-Board members: Shirl Ahrens [Chair], Greg Chesney [VP], Carolyn Hughes [Secretary], Phyllis Sipos [Treasurer], and Pastor Becky. She then presented a report from the Endowment Board.
 - The fund is now a 1.7 million dollar fund; it received 5.7% return in 2014.
 - The church received \$110,000 from the Fund for operating expenses in 2014, or about 30% of the expenses. This is down from as much as 50% in prior years.
- Pastor Becky gave a "State of the Parish" report:
 - Highlighting the many new things in 2014 [Rod & Staff Society, Cindy Roehl, Shepherd's Village, color directory done in-house, joint pet burial, new dishwasher, Rib Fest, Bell Choir— all in addition to many continuing projects.]
 - An outreach total of \$77,000 or 20% of our budget. Her Heartfelt Thanks for all the work behind this!

Program

Andrea Zahn explained "toss the ball", a game for all to join in to get to know and give thanks for each other. After a closing prayer, the meeting adjourned at 1:00 PM.

Getting Up, Going Out, and Grabbing Hold

The Good News

After three years focusing on sprucing up our campus, we're done with all of our high priority projects! In 2013, at the beginning of our capital campaign, Celebrating Our Blessings, we divided the work into three phases, all to be completed without taking on any commercial debt. I am joyful and proud as I report that this community has faithfully kept up with its promised donations, so we could fund and last two bathrooms were finished in December. Every single project has been done with care and great attention, and our home looks wonderful. We will be holding a big celebration of the completion of the campaign this Spring.

The Better News

Because of our careful construction management and several generous in-kind donations of materials, we will have funds remaining, both already in hand and still anticipated from pledges. That means we can turn to some of

the projects in the third phase. The number one priority is making the approach from the paved parking lot to the church entrances and patio area safe, attractive and accessible. This includes leveling the large area with drainage dip (which I have not-so-lovingly called "the Grand Canyon"), installing handrails, and creating a delightful gathering space.

The Best News

As always, though, a church's buildings serve as a base of operations, they are not the ultimate destination. This family of faith has spread far, far beyond its walls to do what Jesus calls his followers to do: feed the hungry, welcome the stranger, clothe the naked, visit the sick and prisoners, and BE good news to the community — our loving efforts have had impacts in Dunedin, the entire Tampa Bay area, and around the globe. As members of the parish find new ways to serve, they ask for partners in ministry and this church family gets up, goes

out, and grabs hold. Our ministry fair in the fall enabled members and visitors alike to explore a huge variety of ways to serve. Today, look on page for our truly breathtaking list of ways we can be servants of God.

In fact, we have so much going on that we formed or reorganized several teams to coordinate efforts, including the Outreach Team, the Year-Round Stewardship Team, the Membership Development Team, the Fundraising Team, and our newest one, the Incubation Team. The ministry of the Incubation Team is to help new ministries to get a solid start. There are several new ministries, ranging from a grief support group to a prison ministry, that are in the early discussion stages. Where might other new ministry ideas come from? You! Everyone at Good Shepherd is a potential ministry-starter. As I've said more than once, if you're bored at Good Shepherd, you're not paying attention. All that said, we are not a social services club, we are the church.

Bells of Hope Handbell Choir

The Bells of Hope had a busy and productive 2015. The group began ringing in the fall of 2014 with eight ringers. As 2015 began there were ten ringers, and it was felt that additional handbells needed to be added to the set. Two new bells, a C#7 and D7 were ordered from the White Chapel Foundry in England, and they arrived in the spring. The Bells of Hope rang in a number of worship services including the Easter Vigil and on Easter Sunday. As some of the ringers began departing for points north the group continued to ring as a smaller ensemble until the end of May.

While White Chapel handbells are considered among the finest made, they do present maintenance issues which can be difficult to address. It was noted that several of our leather handles were in danger of breaking. A search was made of the eastern United States to find a reliable facility that would repair the handbells and none could be located. It was looking as if the bells would have to be returned to



the factory in England when a repairman was found in Colorado who could replace the handles and return the handbells in time for us to begin rehearsals in October. Our grandchildren live in Colorado, and on a trip we made there in September we visited with the repairman in Colorado Springs. The trip was well worth it, as he showed us

many repairs and adjustments that we can make ourselves. The Bells of Hope are very grateful to Good Shepherd for their assistance in getting the bells repaired.

With the bells repaired and a fresh coat of polish applied rehearsals began, and we were pleased to welcome new ringers. We purchased mallets which will bring a new dimension to playing handbells. We are very appreciative to the generosity of our congregation in helping us to obtain the mallets. On Sunday, December 20th we presented our first Carol Sing. The program consisted of handbell ringing, congregational singing and a beautiful duet by Judith and Nels Auger. Robert Shone accompanied the bells and congregational singing on the organ, and the program was led by Jerry Mullinax.

One of the highlights of the Carol Sing was the Shepherd's Village Chimers who rang on the newly acquired set of Malmark handchimes. Shepherd's Village and the Bells of Hope purchased a two octave

set of handchimes in the fall. The Shepherd's Village Chimers began rehearsals in October and quickly mastered the skills of handchime ringing. They played four pieces and ended with an enthusiastic ringing of "Jingle Bells" to the delight of the audience.

The Bells of Hope are looking forward to ringing in 2016 and to learning more complex music. At the Carol Sing a piece was rung which used the "singing bell" technique and other new techniques will be explored as the year unfolds. Shepherd's Village Academic Enrichment Center concluded its first year in June 2015 with an original play, "The Pillow Case Kids" which highlighted all the activities the Villagers experienced during the 2014-2015 school year. Shepherd's Village opened its second year in late August 2015. Our enrollment soared and we are now at capacity, blessed with the most amazing Dunedin families. Michelle and Christine even had to create a waiting list for children who registered after seats were filled. Funding still remains strong thanks to continued support from Honeywell, family, friends and our new donor, The Furniture Thrift Shop.

Our blessings continue with a strong core of co-teachers. The Village has about 12 volunteers who not only help out during special projects, but come every week on regularly scheduled days. A conservative estimate of 900 volunteer hours does not include the time spent planning, preparing lessons, shopping for materials, consulting, emailing and researching.

Pack-a-Sack

During the past year, Pack-a-Sack has provided over 1500 meals to chronically hungry children at two Pinellas County elementary schools in Dunedin. We are currently serving Dunedin Elementary and San Jose Elementary. Each bag of 12 items is either given by gracious donors or purchased through various donations and other funding sources such as the Furniture Thrift Shop. The annual cost for the 44 students we serve comes to approximately \$5,800. Our volunteer hours for this past year total about 900 hours. We have a dedicated group of 12 volunteers who make purchases when necessary, inventory and prepare the items and bag them three Wednesdays per month for distribution to the schools. On one Tuesday per month the students from Shepherd's Village prepare and bag the items as their way of giving back to the community in which they live.



The curriculum at Shepherd's Village is a healthy mix of special projects, creative arts and units in Geography, Physics, and related Mathematical concepts. The children have learned how to read music and play the chimes, helped in Good Shepherd's Pumpkin Patch, and planted another garden. We have studied World and U.S. Geography, enjoyed exploring flags, and have learned that the families of our Villagers represent ten countries from around the globe. Nothing speaks multi-cultural more than the experience of cooking and sharing foods from other cultures! Our snacks tend to get a bit exotic sometimes.

Before this school year comes to a close in June, we will have completed several interesting Units of Study; Fun with Flags, The Village Kitchen, I've Got Rhythm, Physics with Toys, Build Me Up Buttercup (engineering and construction), and It's Sew Easy.

The fun never ends at the Village!

On March 1, 2012 the Church took a leap of faith and opened a thrift store dedicated to the sale of "experienced furniture and appliances." Located three miles south of the Church at 1714 North Fort Harrison on the edge of an area that desperately needs our help, the store has been a blessing three times over. We sell good stuff to people who wouldn't be able to afford it, at prices they can handle. We give them hope for better times. We take our proceeds and support local food pantries, soup kitchens, and safe havens for battered women and the homeless. Last, we are dedicated to funding a capital reserve for Good Shepherd so that this Church may physically preserve itself and continue to do God's work long after we're all gone.

Look How We've Grown

In our first year of existence; that is through December 31, 2012 we distributed a total of \$3,660 to Outreach Ministries and the Endowment Fund. Not bad, eh?

Well, fast-forward to the end of 2015. Last year we distributed \$67,000.00 to Outreach Ministries and the Capital Reserve Fund. We have more than quintupled our space and volunteers (both a necessity) and now sell just about anything you can think of.

We have a host of male and female church member volunteers who have adopted our mantra "sell a couch" with zeal. We also have a bevy of non-member volunteers who are reclaiming their self-respect and "paying forward." All have been called to serve...

Which brings me to y'all (as Becky would say). The Stores are open from 9:00 a.m. to 3:00 p.m. daily, Monday through Saturday. If you, or someone you know (member or not) would be interested in working with us, track us down. Your time commitment is as flexible as you want it to be. Except for the occasional electric shock discipline for mistakes made, the operation is very low stress. (Okay, there's no ESD. We made that up just to see if you were still reading.) If you thought about it in the past, or tried to volunteer before but didn't hear from us, or want to try something new this year... come and join us. We'd love to have you.



Endowment Fund, Inc.

Mission

Incorporated in 1963, the Endowment Fund was created to receive gifts to be managed for the benefit of The Church of The Good Shepherd. The corporation is subject to the Constitution and Canons of The Diocese of Southwest Florida, Inc. "This Corporation shall have *perpetual existence*" according to the Articles of Incorporation.

Management

The Endowment Fund is governed by its Articles of Incorporation and Bylaws. In accordance with those documents, the management of the Endowment Fund is overseen by a five-person Board of Trustees consisting of the Rector as member ex-officio and four members of the Parish elected at the annual meeting. Lay members of the Board serve for three-year staggered terms to ensure continuity of management, and are eligible for re-election. Trustees elect their respective officers annually. The officers of the Board and the year their terms as Trustees conclude are as follows:

Phyllis Sipos is the trustee candidate for the three-year open term.

Accomplishments

1. In 2015 we welcomed additional members into **The Rod & Staff Society**. This legacy Society was started in 2013 to recognize and thank those individuals and families who have committed to Good Shepherd's ministries and vision by remembering the Endowment Fund in their estate plans through a documented planned gift. In 2014, Laurel Banta, joined our other Society members: Shirl Ahrens, Robert Brook, Don Chandler, Sharon DeVore, Lela Highsmith, Carolyn Hughes, Kam McDaniel and Judy Warner. Our newest members, added in 2015, were Joanne and Doug Forsythe, and Jorgelina and Miguel Solari.
2. The board is happy to report that the contractual agreement for a Line of Credit loan in the amount of \$97,000 to The Church of The Good Shepherd in 2012 (which was used solely for the restoration of the Church building) has been repaid in full and, early.
3. Newsletter articles and a Mission Moment were shared with parishioners to educate them about end-of-life issues including making a planned gift

to the Endowment Fund, documenting that gift and becoming a member of the new Rod & Staff Society.

4. The Board has worked diligently in a collaborative effort with the Finance Committee and the Vestry to educate and implement the Investment Policy Statement for the Endowment Fund of The Church of the Good Shepherd, particularly the spending policy limitations.
5. ProVise Management Group, LLC (Clearwater, FL) has managed the Fund for the past six years. The Board maintains close communication through emails, monthly and quarterly statements as well as personal presentations by ProVise advisors at our Board meetings.
6. The Board retains the accounting firm of Tax Solutions Plus to provide the record keeping in accordance with the Diocesan stated requirements. The firm maintains the books and records, prepares quarterly and annual financial statements and associated notes in accordance with the Statements on Standards for Accounting and Review Services established by the American Institute of Certified Public Accountant.
7. The annual internal audit, in accordance with Diocesan guidelines, was completed successfully and resulted in the desired "unqualified" opinion. Two minor recommendations from the church Audit Committee to facilitate their work are being implemented.

Goals

1. Continue to monitor with the Vestry the fiscal policies of the Church while adhering to the spending policy articulated in the IPS and continue to lessen the planned dependency on the Endowment Fund for the operation of the Church.
2. Continue to re-imagine and update the parish website for maximum communication.
3. Continue to review investment results and performance with the investment management team on a periodic basis, at least semi-annually, and to ensure that all adhere to the approved long-term Investment Policy of the Fund and adhere to the (F)UPMIFA.
4. Continue to educate and counsel parishioners about the purpose of the Endowment Fund and about vehicles available to make contributions to the Fund that are often tax-beneficial to contributors. Gifts of appreciated securities or other appreciated assets, 401(k) or IRA accounts, and Life

Insurance Policies can all be gifted (totally or as a percentage) directly to the Endowment Fund with tax benefits. A particular percentage of an estate or a dollar value may be gifted to the Endowment Fund in one's will or trust. Board members will be able to assist with information and direct you to an objective and free advising service at ProVise or you may wish to consult with your estate planning attorney.

Investment Results for 2015

The approximate net market value of the Fund on December 31, 2015 was \$1,724,423 compared to \$1,741,670 on December 31, 2014. This reflects a decrease in market value of \$17,246. The Fund portfolio's performance (time weighted), net of all fees and expenses was a decline of 2.15%. Capital gains of about \$358,500 were realized during the year.

Investment income was approximately \$54,300 during the year. Other income for 2015 included \$33,425 from the Furniture Thrift Store; \$2,625 from interest on

the LOC draws; and \$303 from a litigation settlement. In addition, the fund received \$97,000 from the early LOC payoff from the church. Planned gifts were received by the Fund this year (Forsythes and Solaris), as well as a contributions, but no gifts were received from parish estates.

Disbursements to the Church for the year 2015 totaled \$110,400 for general operating expenses of the parish. Trustee management fees totaled a little over \$10,600 while accounting fees totaled \$1,900. Other expenses paid during the year were \$5,000 for plumbing repairs on the Rector's house, \$61 for licenses and permits, \$24 for bank service charges, and \$24 for Rod & Staff plaque name plates.

Annual net income for the Fund for 2016 is estimated at \$29,000. As of December 31, 2015 the asset allocation of the investment portfolio was approximately 60% domestic equities, 9% international equities and 31% fixed income securities and/or cash equivalents.

Good Shepherd is the church it is today in large part due to the foresight and generosity of donors who have made planned gifts. Remembering the Endowment Fund in your will/trust is the most enduring statement you can make about your belief in our Christian mission.

Episcopal Relief and Development

Good Shepherd's 2015 Episcopal Relief and Development activity continued to show that we, as a community, have our hearts and heads in a good place. Over the last four years this Community in general and this Congregation in particular has funded the purchase of malarial netting, micro-loans for women, fresh water wells, and a variety of livestock for third world villages from the ERD "Gifts for Life Catalog." We have been able to do this primarily through your support, both with donations and attendance at our special events... the Low Country Shrimp Boil in March and the RibFest in December.

Two Fundraisers

The March Shrimp Boil has become a signature event at the Church. In 2014, Two hundred thirty-five [235] people came to support the purchase of a bevy of chickens, pigs, and cows. How many of you remember what a "mooooooo...ving" experience it was? Well, we netted just under \$5,800 and bought EIGHTEEN PIGS, THIRTEEN FLOCKS OF CHICKENS, and THREE COWS.

In December the Good Shepherd Episcopal Relief and Development crew swapped ribs for shrimp. The ministry of the RibFest was to once again fund the purchase of a village well in Nicaragua. Two hundred nineteen (219) people came from the church and larger community. As a result of the festival, over \$5,000 was netted for the cause; enough to fund a complete installation of a well.

For both of these events, the silent auction, raffle, dinner, and ...my favorite... desserts were all spectacular! All in all, a grand time was had by all, with good food, good fellowship, and parish involvement, for good causes.

2015 Donations Totaled \$12,811.59

Our Discretionary Fund Team assists the Rector with the disbursement of funds. As calls for assistance are received, information is gathered and sent to the Team members. Their responses are usually received by the office within 24 hours. The original caller calls back to receive the decision from the committee. The nature of the call and availability of funds, will determine if the client is helped, and how much financial assistance is given. The church had 310 requests for help from families with utility bills. Because of the generous gifts, our Rector's Fund was able to assist 154 families in the Clearwater/Dunedin area during 2015.




