Opening

Brotherhood of Good Shepherd

The Brotherhood of Good Shepherd is a men's group helping Good Shepherd grow. Our main agenda is to use fellowship, outreach and evangelism to attract new parishioners to Christ Jesus, through the work he has called us to do.

We have chosen to feed the flock with a breakfast every third Sunday and collect a small sum to cover cost and use any earnings for our outreach work.

Our December earnings allowed us to give \$300 to Pastor Becky's Discretionary Fund for the needy at Christmas time. We were proud to use the breakfast earnings from the May 16th breakfast to contribute \$265 to the Mission Trip for the Good Shepherd Team going to the Dominican Republic. In June we gave another \$250 dollars to the Dominican Development Group from previous earnings.

We also donated \$250 to Episcopal Relief and Development for relief in areas of the US that have suffered from tornados and flooding.

Our Past and Future

In 2010, we contributed \$200 to the general fund to help with expenses and donated \$87 to Nets for Life the ERD program.

Rector's Discretionary Fund

Through the generous support of members and friends of Church of the Good Shepherd donations were received designated to the Rector's Discretionary Fund...

- The loose offering collected the First Sunday of each month totaled \$3,425.72
- All offering collected at Pastor Becky's Installation Service was designated to the Fund, and that totaled \$1,181.00
- Other donations by individuals and groups throughout the year totaled \$2,792.00

2011 Donations Totaled \$7,398.72

Because of these generous gifts, our Rector was able to assist thirty-four members of the community with a variety of financial needs. Many sought our help only once; others required assistance more often. The Rector listened to each need and when funds were available, assisted as we were able.

Note: There was a carry-over of funds from 2010. This allowed the Rector to disburse more in 2011 than was received.



Religious Community Services (RCS)

During 2011 we continued the collection of coins in baby food jars. The money collected was given to RCS to purchase food for infants.

Total collected: \$464

Each month we also encouraged Bagzilla, where donations of food were blessed and then sent to the Food Bank. A remarkable 3,722 pounds of food was collected in 2011!

Episcopal Church Women

The Episcopal Church Women (ECW), of which every woman in the church is a member, is overseen by a steering committee. Monthly meetings are held on the second Monday of each month where business is discussed and decisions are made.

Our main source of income is our Little Thrift Shop located at 506 Main St., in downtown Dunedin. The monies made in the Thrift Shop fund our proposed expenditures, a copy of which is below.

Other things we do during the year is to assemble and deliver the "Care Bags" for the migrant workers in Dade City. We participate in the Classroom Partnership Program of the Pinellas County School System. We are in partnership with four classrooms, two

at Dunedin Elementary and two at San Jose Elementary. We support our Relay for Life team in their efforts to raise money for the American Cancer Society. We have two United Thank Offering (UTO) ingatherings each year, and one Church Periodical Club (CPC) Sunday. Also, we enjoy decorating Kirk Hall for Christmas.

Any woman in the church who is interested in learning more about the ECW is welcome to attend one of our second Monday meetings, which are held at 4:00 p.m. in the Patio Room. We look forward to seeing you there.

Endowment Fund, Inc.

Mission

The Church of The Good Shepherd Endowment Fund, Inc. (the Fund) is a separate entity authorized by the Parish and incorporated on May 3, 1963 as a not-for-profit organization existing under the laws of the State of Florida to elicit and receive gifts of property of any kind to be held in trust for, or to be administered on behalf of or distributed to, and for the benefit of the Parish. The corporation is subject to the Constitution and Canons of The Diocese of Southwest Florida, Inc., one of the dioceses of the Protestant Episcopal Church in the USA. "This Corporation shall have perpetual existence" according to the Articles of Incorporation.

Management

The Endowment Fund is governed by its Articles of Incorporation and Bylaws. In accordance with those documents, management of the Endowment Fund is overseen by a five-person Board of Trustees consisting of the Rector as member ex-officio and four members of the Parish elected at the annual meeting. Lay members of the Board serve for three-year staggered terms to ensure continuity of management, and are eligible for re-election. The offices of the Board and the year their terms as Trustees conclude are as follows:

Joe Nixon will not seek reelection, but Shirl Ahrens will seek reelection. Both vacancies are for three-year terms. Carolyn Hughes is the other trustee candidate.

The Board wishes to recognize our departed brother in Christ and faithful former trustee, Jack Spalding, who died on October 1, 2011. Jack served so faithfully for 5 years (1998-2002) on the Endowment Board and served in so many other capacities with his time, talent and treasure at Good Shepherd prior to moving to Dade City.

Accomplishments

1. The Board presented an eight-session educational seminar series in the fall entitled, *Last Things First*, dealing with end-of-life issues about our health care choices, our planned gifting to the Endowment Fund and our memorial service planning.

2. Monthly newsletter articles were written to educate parishioners about the why's, how's, and what's of making a planned gift to the Endowment Fund as well as articles promoting the *Last Things First* topics.
3. The Board has worked diligently in a collaborative effort with the Finance Committee and the Vestry to educate and implement the new Investment Policy Statement for the The Endowment Fund of The Church of the Good Shepherd, particularly the spending policy limitations.
4. Board member, Joe Nixon, presented to the Finance Committee and Vestry the need to separate capital expenditures from the Church operating budget, thus developing a Capital Reserve Fund. Follow-up action is being taken.
5. During this second year that ProVise Management Group, LLC (Clearwater, FL) has managed the Fund, the Board maintained close communication through emails, monthly and quarterly statements as well as personal presentations by them at Board meetings.
6. The Board retained the accounting firm of Tax Solutions Plus to continue the record keeping in accordance with the Diocesan stated requirements. The firm will maintain the books and records, prepare quarterly and annual financial statements, and associated notes in accordance with the Statements on Standards for Accounting and Review Services established by the American Institute of Certified Public Accountants.
7. The annual internal audit, in accordance with Diocesan guidelines, resulted in the desired "unqualified" opinion.

Goals

1. Continue to review investment results and performance with the investment management team on a periodic basis, at least semi-annually, and to ensure that all adhere to the approved long-term Investment Policy of the Fund.
2. Continue to monitor with the Vestry the fiscal policies of the Church while adhering to the new spending policy articulated in the IPS and move toward a planned zero-dependency on the Endowment Fund for the operation of the Church.
3. Create a membership Society to recognize any person who has notified the church that he/she has made a provision in his/her estate plans for a gift to The Church of the Good Shepherd Endowment Fund, Inc. This may include a bequest in a

will or trust, a life income gift (charitable gift annuity, charitable remainder trust, or pooled income fund), a gift of life insurance, or other type of planned gift.

4. Continue to use and update the parish website for maximum communication.
5. Continue to educate and counsel parishioners about the purpose of the Endowment Fund and about vehicles available to make contributions to the Fund that are often tax-beneficial to contributors. Gifts of appreciated securities or other appreciated assets, 401(k) or IRA accounts, and Life Insurance Policies can all be gifted directly to the Endowment Fund with tax benefits. A particular percentage of an estate or a dollar value may be gifted to the Endowment Fund in one's will or trust. Board members will be able to assist with information and direct you to an objective and free advising service at ProVise or you may wish to consult with your estate planning attorney.

Investment Results for 2011

The approximate net market value of the Fund on December 31, 2011 was \$1,662,958 compared to \$1,802,511 on December 31, 2010. This reflects a decrease in market value of \$139,500 or 7.7%. The **net** market value decrease was 0.17% after all fees and disbursements to Good Shepherd Church. However, the actual **net** return on the portfolio was 2% for the

year 2011. Investment income was \$50,807 during the year. Other income for 2011 includes \$510 from a securities litigation settlement and \$285 from memorial contributions. No contributions were received from parish estates.

Disbursements to the parish for the year 2011 totaled \$ 175,302: \$152,193 for general operating expenses of the parish and \$23,109 for capital improvements. Trustee management fees totaled \$10,952 while accounting fees totaled \$1850. Other expenses paid during the year were \$61 for licenses/fees and \$24 for bank service charges.

As of December 31, 2011 the asset allocation of the investment portfolio was approximately 66% domestic equities, 7% international equities and 27% fixed income securities and/or cash equivalents. This compares to 63% domestic equities, 7% international equities and 30% fixed income securities at the end of the prior year. No funds are invested in derivatives, alcohol or tobacco products.
