- IV. Call to Order
  - The meeting was called to order at 10:45AM and a quorum was declared by Rev. Whitney.

# A. Approve Annual Meeting Minutes February 13, 2022

# B. Presentation and Election of Candidates

#### 2. Endowment Board

- Carolyn Hughes, President of the Endowment Board, announced that the candidate for the Endowment Board is Jim Ratliff.
- A motion to approve the candidate by acclamation was made by Andrea Zahn.
- The second was by Maureen Belote.
- Approved.

# V. Reports

#### A. Endowment Fund

- Carolyn Hughes recognized the members of the Endowment Board: Andrea Zahn, Marc Wigmore, Jim Ratliff and retiring member Scott Hood.
- She spoke briefly on the Rod and Staff Society (founded 15 years ago) which is a group that pledges to bequeath a gift to the Endowment Fund upon their death.
- Two recent donations to the Endowment Fund were from Ted Hughes and Brian Sharpe
- Carolyn spoke briefly concerning the Stock Market which is currently down 20%, but through careful investments the Endowment Fund is only down by 12%.
- She also noted that the Endowment Board will continue to work closely with the Vestry.
- She or any member of the Board are always available for questions from the parishioners.

#### B. Finances

- Treasurer Robin Megel gave a report on the parish finances.
- She recognized former Treasurer, Joe Nixon, who was instrumental in organizing the financial records.
- Robin spoke about the recent stewardship theme, "Thriving in Faith and Generosity".
- She noted that the past few years have been difficult with a number of events including the call of a new Rector, the pandemic and the recent economic downturn.
- In spite of many obstacles the parish has thrived.
- Robin spoke of the Mission and Ministry of the parish.
- Bagzilla collected 8K pounds of food which was 45% more than in 2021.
- \$7K in monetary donations was received.

- Total Outreach for the year was \$116K which is the first time this figure has exceeded \$100K since the pandemic.
- There were \$48K in Restricted Funds donations which include Pack a Sack, the Quilters and Episcopal Relief and Development.
- \$28K was donated to the Rector's Discretionary Fund which helps those in the community with rent and utilities.
- The Diocesan tithe for Missions was \$15K.
- \$22K in donations was received from the Furniture Thrift Shop and \$5K from the Episcopal Church Women.
- Volunteer hours were: 7K Furniture Thrift Store; 1100 Pack a Sack; 1700 Quilters; 319 Parking Lot Team; 760 Worship (which includes the Altar Guild, worship servers, flower ministry and administrative assistants) and 473 other hours.
- Total reported Volunteer Hours were 11,683.
- Concerning the day-to-day Operations of the parish: income was \$305K (contributions) which is 5% more than the previous year.
- Contributions account for 75% of the Operating Income.
- There was the 4% draw (\$66K) from the Endowment Fund with \$35K of additional funds for the Rectory Improvement Project.
- Other income was approximately \$36K from the Furniture Thrift Store, lease of Peace Park by the City of Dunedin, Parking Lot Team, and facility usage.
- The total Operating Income of \$409K was 4% more than the previous year.
- The parish received \$25K from a Grant from the American Rescue Plan Act (ARPA).
- These monies can only be used to support non-religious projects.
- From the funds, Pack a Sack received \$12K; Rector's Discretionary Fund \$3K and \$10K for a Restricted Account for Outreach.
- Operating Expenses for 2022 were \$407K with Personnel (\$247K) and Building and Grounds (\$87K). Personnel accounts for 61% of the budget and Building and Grounds, 22%.
- Other expenses were \$72K which is 17% of the budget.
- These include the Diocesan Tithe (\$34K); Administration (\$17K); Music Ministry (\$7K); Outreach (\$4K) and Property Taxes (\$5K)
- The 2022 Budget Deficit was estimated at \$36K.
- Operating Income was \$7K over budget; Operating Expenses were \$31K under budget which left a year-end budget surplus of \$2K.
- Year end balances for 2022 were: Endowment Fund \$1.7M and Operating Cash \$41K.
- Restricted Funds balance was \$242K which includes the Operating Reserve, Capital Projects and Vestry Designated Funds. This compares with \$192 at the close of 2021.
- Capital Expenditures were \$22K for the purchase of a truck for the Furniture Thrift Store which will be subject to the Diocesan tithe of 10% in 2024.
- For the 2023 Budget: Contributions (\$305K); Endowment (\$68K) and Other Income (\$55K) for a total of \$429K. Total Expenses are \$456K with a budget deficit of \$27K.
- In thinking about future planning: there are \$66K in Operating Reserves (equal to two months of expenses); \$54K in Vestry Designated (\$40K approved to be transferred to Capital Projects to fund the Rectory Improvement Project); \$5K for solar project and \$35K for Capital Projects (funding for the Rectory Improvement Project).
- In conclusion the parish is truly grateful, thankful and blessed.

#### RECTOR'S REPORT

Dear Good Shepherd,

I am close to reaching the three-year mark as your Rector and I am truly honored be in Ministry with you here at Good Shepherd. 2023 brought many changes and many blessings for both Good Shepherd and for my growing family.

In March, Steven and I welcomed our first child, Maggie, into the world and you embraced her so lovingly. I am grateful to have had 12 weeks of Maternity leave to be home with her. Rev. Kathy Walter, Deacon Cindy, Mary Ratliff (Sr. Warden), our staff, and many volunteers kept things running while I was away. They ushered COGS through Holy Week and Easter, the busiest time in the life of the church. Maggie was Baptized on All Saints Sunday at Good Shepherd.

2023 showed the culmination of over a year's work discerning the best course of action regarding the church owned houses on Edgewater Dr. and Albert St. After diligent work by a task force, continued conversation by the Vestry, it was decided to rearrange living arrangements. In June, my family moved into a temporary Condo, the Edgewater House was painted, and Garry Lumm (our Sexton) and his wife Jennifer moved from the Albert Street House to Edgewater Dr. and have settled in. After three months of renovations to the Albert St. house, Steven, Maggie, and I moved in at the end of September, right on time. We are loving our new home and are excited to raise our family in it.

In the fall of 2023 after a request from the Board of the Furniture Thrift Store and a commissioned task force, the Vestry made the decision to list the Furniture Thrift Store building for sale. It went on the market shortly after Christmas. This is a valuable ministry to the church and community and it will be missed. The FTS continues to function and plans to continue until a sale is finalized, and we hope to find new ways to minister to those whom the thrift store served on a daily basis.

The primary thing we do together is worship in community. We continue to offer In-person and online worship opportunities, allowing worship to be accessible to even more of our congregation including the homebound and the sick. We have baptized new members into the body of Christ, buried some beloved parishioners, and took home communion to many of our parishioners. Our altar guild, flower guild, choirs, acolytes, servers, ushers work diligently to enhance our Worship.

The Church of the Good Shepherd continues to give generously to the wider community through ventures like Pak-a-Sack, Dunedin Cares, Hurricane Relief, The Rectors Discretionary Fund (which assists families with utility bills), the Furniture Thrift Store, and many others that seek to meet the need of others.

Opportunities for formation have continued as well, for both children and adults. Starting with my maternity leave, Deacon Cindy took over adult formation between services and will continue until they finish the Book of Romans. Our children continue to have formation during the first part of our 10am service. We have other various opportunities from Walking the Mourners Path to Creative Spirituality, to special Lenten programming

# **WORSHIP**

#### LITURGY

Liturgy means "the work of the people," and indeed, here at Church of the Good Shepherd our liturgy is just that. From our Sunday and weekday worship, to our special seasonal worship and all of the things that happen in between such as weddings, funerals, and baptisms, there are many people who make our Liturgy and Worship possible. Our Musicians, acolytes and servers, ushers, Altar Guild, Flower Guild, technology team, and many more all work hard to make our worship possible.

Our worship is central to who we are and what we do here at The Church of the Good Shepherd. In the following pages you will find just some of the many groups and guilds that make it all possible.

#### MUSIC MINISTRY

I am thankful for the opportunity to continue serving as the Organist/Choirmaster at Good Shepherd and for the relationships that we have developed here.

We were finally able to drop the mask requirement in January due to covid being more under control and are grateful that most of us stayed healthy.

It is a pleasure to work with a creative and helpful staff including Pastor Whitney. In August, our cantor/tenor soloist Julian Guini left after three years in the position. Many offered special gifts to him and we had an after church reception in his honor in April (although he stayed till August so that folks who leave in the summer could participate.) We also lost by death soprano, Carol Zaffiri in November. Carol had sung with us since October 2021. The choir has remained faithful and works hard to produce excellent music.

The work of securing new choir vestments was completed and the cassocks and cottas arrived over the summer, ready for the choir's return in October. They look great and I think makes the choir sound better! The old robes were in disrepair with broken zippers and mis-matched colors.

Bells of Hope handbell choir continues to ring at least monthly during the season (October-April) and I'm grateful for the volunteer leadership of Pat Cates who devotes many hours with the bells. We once again presented the annual Carol Sing on December 17. (read more about the bells in Pat's report).

My duties primarily include playing our wonderful Zimmer pipe organ (sometimes the keyboard) for worship services, leading the adult vocal choir, and choosing the hymns and service music.

There are still some issues that need to be addressed with the organ and we will do some of those in 2024. In December 2021 we began a relationship with the organ company William Longmore and Associates who has been very helpful and responsive in addressing our needs.

Outside the walls of the church, I am active in the Clearwater chapter of the American Guild of Organists and chair the scholarship committee of AGO as well as edit and produce the monthly newsletter, *The Windline*. I also performed a solo organ recital at St. Anne of Grace Episcopal Church in Seminole as well as made a concert appearance on the new organ at St. Alfred's Episcopal, Palm Harbor. In June at a yearly week-long church music Workshop, I served as worship planner, organist for the worship services and adult choral accompanist. These things give Good Shepherd recognition in the community.

I am thankful to be here at Church of the Good Shepherd working with a congenial and dedicated staff as well as an appreciative congregation.

#### **BELLS OF HOPE**

The Bells of Hope experienced another wonderful year of ringing and continued to present beautiful music for our worship services. With the Stewardship Program beginning we worshipped at 9:00 AM in our new Vestments which were blessed during the service. We rang the Austrian Hymn, "Glorious Things of Thee are Spoken" as the Opening Voluntary with Tom Huffman and a guest trumpet player. We also rang as part of the Stewardship Hymn, "Lord, You Give the Great Commission".

Before we knew it, we were in preparations for Christmas and our Annual Carol Sing. We rang "Praise to the Living God" in November, and in December we were honored to ring "An Advent Trilogy" with a guest flautist. We presented our annual Carol Sing on December 17th. There had been heavy rains on the Friday and Saturday prior to the Sing, and we worried that this might affect the attendance. When the event began the Sanctuary was filled with a wonderful group of parishioners and community members who raised their voices in Carols of the season. Mary Ratliff provided excellent leadership to the audience who sang a number of spirited Carols accompanied by Tom Huffman (organ), Emily Cantin (trumpet), Dylan Cantin (percussion) and the Bells of Hope. We were also blessed by the use of the timpani from Countryside High School.

We are looking forward to being part of worship at the Church of Good Shepherd in 2024.

#### FLOWER TEAM MINISTRY

The Flower Team consists of volunteers which are both church members and non-church members. They work under the guidance of the Rector and the Holy Spirit to supply the Altar Flowers at all services as needed at the Church of the Good Shepherd.

The Flower Team follows the Liturgical Calendar for the Episcopal Church. Two large vases are arranged with fresh flowers prior to the Sunday morning service and are then removed from the church Monday mornings and donated to the charity "Random Acts of Flowers" for reuse. The vases are then cleaned and stored. The Flower Team purchases the flowers and other required materials. These are all stored at Good Shepherd in the flower Room located in Kirk Hall.

The Flower Team may occasionally try to accommodate requests for special flowers for weddings, funerals, and baptisms – but only as part of the regular service flowers.

The Fresh flower purchases are made using a Church of the Good Shepherd Publix card. Sometimes flowers must be obtained from sources other than Publix, in which case a receipt is turned in for reimbursement.

Flower Team Members use a rotating flexible schedule. Members include Maryellen Tilly, Katherine Woods, Judy Kern-Bertram, Donna Charles, Elana and James Goletz.

# **FURNITURE THRIFT STORE (FTS)**

During 2023, The Good Shepherd Furniture Thrift Store (FTS) Cash and Credit Card Sales were \$195,934, compared to \$184,344in 2022, an 5% increase of \$9,590 in 2023 over 2022. Operating Expenses in 2023 were \$161,196 compared to \$136,929 in 2022. Major differences included \$1,271 in Property Insurance, \$926 in Debit/Credit Fee, \$17,042 in salaries and related expenses, \$1,776 in Electric, \$2,506 in Miscellaneous expenses and \$4,293 in Store maintenance and repairs. Operating Expenses were under budget by \$10,914 in 2023. As part of operating expenses, the mortgage on the building was reduced by \$29,815.54 in 2023, leaving \$170k still owed to the Diocese Net Operating Income in 2023 was \$34,738 compared to \$47,414 in 2022, attributable to increases to payroll, property insurance, and building repairs. Current Cash Balance is \$5,164: \$100.00 in cash register, \$3,000.00 in Contingency Reserve and \$2,064 in Operating Funds.

Volunteer Hours for 2023 Church members totaled 5,167 hours and non-church members 2,095 hours for a total of 7,262 volunteer hours.

Charitable Distributions from revenue in 2023 were \$32,363 compared to \$44,815 in 2021. Here's the breakdown:

In addition to Charitable Distributions to other missions, FTS provides jobs to employment challenged individuals from the neighborhood, who can walk or bike to work. We consider this part of the ministry. Wages for the employment challenged in 2023 were about \$65k,

compared to \$47k in 2022. All four truck workers, and one store worker are paid.

In addition to Charitable Distributions from revenue, the FTS supports these missions lending space and inventory.

- <u>Dunedin Cares</u> food distribution at the store has been very much appreciated in the Greenwood neighborhood. Each month, on the 2<sup>nd</sup> and 4<sup>th</sup> Wednesday, In 2023, Dunedin Cares volunteers gave away 4.2 tons of food to local families.
- The Boys & Girls Clubs of SunCoast provide hydroponic lettuce in addition to The Food Rescue Connection have partnered with Publix at Granada Plaza to provide pizza slices, bagels, breads, baked items, fresh vegetables and fruits. Each week, Frank Kneen picks up food and delivers to the FTS. In 2023, we gave away value of food worth \$19k.
- The FTS provides modest clothing, housewares and furniture gifts directly from inventory to: a) people who are homeless need a change of clothes from time to time (we let them take one or two changes of clothes) and b) people who are graduating shelters and can't afford to furnish their new home. These in-kind charitable gifts are too difficult to individually track and value, so we attribute it to divine mercy.

On January 14<sup>th</sup>, we held the FTS Annual Meeting and elected new Board members. Please join us in thanking Dave Dube for his dedicated service to this ministry. New Board members elected were John Schmidt and Ken Tomlinson. At the first Board meeting, these officers were elected: Chair – Sandy Kneen; Vice-Chair – Tony Bowman; Treasurer – Ken Tomlinson; Secretary – Caroline Maisel.

Finally, the Board would like to thank the Holy Spirit, without whom none of this would be possible, all the volunteers who give their time in the spirit of True Love.

#### PACK-A-SACK

During the past year, Pack-A-Sack has provided over 4,000 meals to chronically hungry children at two Pinellas County elementary schools in Dunedin. We are currently serving Dunedin Elementary and San Jose Elementary. Each bag provides 11 shelf stable items purchased through generous donations from our parish, a Diocesan Charities grant, ECW, the church budget, and fund-raising efforts. The annual cost for the 120-130 students we currently serve comes to approximately \$20,000 for this school year. Our volunteer hours for this past year total over 925 hours.

We have a dedicated group of 13 volunteers who make food purchases, inventory stock, and prepare the items and bag them each Wednesday morning for distribution to the schools. Garry Lumm continues to be our delivery person, to the two schools. This year we have been ordering about half of our food items from Amazon. The remaining items we can obtain at the local Save-A-Lot. Our milk has again remained a no cost item thanks to the food bank at the Free Clinic of St. Petersburg.

The Pack a Sack volunteers remember fondly Deborah Bouvier, one of our founding members. Her devotion to this ministry will be our guiding light in the future.

The Pack a Sack ministry wishes to thank all those who have contributed in any way to the success of this ministry. We continue to enjoy our service in this important outreach ministry.

#### PARKING LOT TEAM

2023 was a year of miraculous success in raising funds for our Church operation! The efforts of our parking team were nothing short of sheer loyalty, diligence and committed service. And for that we are all so very grateful. I wish to acknowledge the additional leadership that Dave Megel has given to this ministry in becoming the on-site events manager as of October 2023. Dave has also initiated/developed using a QR code to assist in giving a donation for parking via a credit card. This ministry serves to accommodate public parking in our paved and unpaved parking lots on the church campus. Team members assist the public in finding a parking spot in one of our lots while serving for 2-3 hour shifts (or more!) during the downtown special events.

We monitored our parking lots for 11 Special Events on 14 days during 2023 and raised a total of \$26,994 through the suggested donation of \$10 per car.

Monies reported herein do not include parking lot income from boat trailer parking donations throughout the year or private agreements for those needing off-street parking. The income listed is only from the Parking Team ministry.

# PRAYER QUILT/CRAFTERS GROUP

In 2014 the Church of the Good Shepherd prayer quilt group was started by Deborah Bouvier, who sadly passed away in December 2023. She began this group to provide quilts of comfort and healing to parish family and friends who were going through medical difficulties. This wonderful lady was the inspiration and the guiding light to many who learned to quilt under her tutelage. In 2018 this group has expanded its membership, to other parish crafters, and its mission, to include raising funds for other church ministries, primarily Pack-A -Sack.

During 2023 ten prayer quilts were gifted. The group also gifted a quilt to baby Maggie and made many other items for Maggie's baby shower. They contributed two wall hangings to the church for display in the sanctuary, an Easter hanging, and "Unto Us a Child is Born", a Christmas hanging.

The group then focused their attention towards making quilts and other items for sale. They made quilts, wall hangings, pillows, table runners, pot holders, tote bags, aprons, tree ornaments, original works of art, stuffed animals, greeting cards and other crafts. The group held its annual craft and quilt sale in November, in conjunction with the Dunedin Downtown Arts and Crafts Festival. As a result of these efforts, they were able to raise almost \$9,000 to support the Pack A Sack program. They are planning a spring craft and quilt sale to be held in April 2024.

Over 1,800 volunteer hours were devoted to making prayer quilts and the items sold during 2023.

#### **DUNEDIN CARES**

The Church of the Good Shepherd was able to contribute 4,259 pounds of food and \$17,631.40 in 2023 to Dunedin Cares Food Pantry, mostly collected on Sundays and funds contributed from the Furniture Thrift Store. Through donations they are able to accomplish their mission of striving to alleviate hunger by providing food to our local community.

#### FARM WORKERS MINISTRY

COGS Parishioners and Crafters were very generous in their responses to the appeal for Christmas gifts for farm workers and their families in Dade City, FL. The gifts were taken to Farmworkers Self-Help, Inc., where they give gifts to over 200 families each Christmas. These gifts were received there by Margarita Romo.

In addition to many handmade blankets and other items made by the Crafters, a generous monetary gift from the Furniture Thrift Store (as well as a large number of used jeans for work in the fields), and hundreds of dollars in actual gifts put in the bins, over \$800 was donated to the Farmworker Fund. Gifts were purchased with much of that money and the remainder was sent as a check for further Christmas needs and to replenish their weekly food bank.

This yearly effort is our small way of saying "Thank You" to the workers and their families who do so much to improve the quality of our lives.

#### RECTOR'S DISCRETIONARY FUND

Donations to the Rector's Discretionary Fund were received in 2023 through the loose offering on the first Sunday of each month, donations by individuals and groups, and donations to the Rector for weddings, baptisms, funerals, etc. The Furniture Thrift Store is also a large contributor to the Fund.

2023 Donations Totaled - \$22,074.71

Our Discretionary Fund Team assists the Rector with the disbursement of funds. The team takes calls for one day during the month. Only calls received that day between the hours of 9:30 a.m. and 12:00 p.m. are put on the list of those requesting assistance for a utility bill.

The advantages of this method are that the team has a larger checking balance to distribute and team members can come in the office to assist in taking the calls. There is also less postage involved in mailing utility payments for the clients and the office administrator can consolidate the hours spent on the Rector's Fund paperwork.

The Team and Reverend Whitney were able to process 158 requests for assistance during 2023. \$20,011.00 Power Bills \$3254.36 Water/Gas Bills \$530.00 Other Needs

#### ENDOWMENT FUND, INC.

#### Mission

Incorporated in 1963, the Endowment Fund was created to receive gifts to be managed for the benefit of The Church of The Good Shepherd. The corporation is subject to the Constitution and Canons of The Diocese of Southwest Florida, Inc. "This Corporation shall have *perpetual existence*" according to the Articles of Incorporation.

#### Management

The Endowment Fund is governed by its Articles of Incorporation and Bylaws. In accordance with those documents, the management of the Endowment Fund is overseen by a five-person Board of Trustees consisting of the Rector as member exofficio and four members of the Parish elected at the annual meeting. Lay members of the Board serve for three-year staggered terms to ensure continuity of management, and are eligible for re-election. Trustees elect their respective officers annually. The officers of the Board and the year their terms as Trustees conclude are as follows:

President ....... Carolyn Hughes 2024
Vice President ... Marc Wigmore 2025
Secretary ...... Jim Ratliff 2026
Treasurer ....... Andrea Zahn 2025
Ex-officio Rev. Whitney Burton

Carolyn Hughes is running for another 3 year term on the board as her current term ends with the annual meeting.

#### Accomplishments

- 1. The Rod & Staff Society. This legacy Society was started in 2013 to recognize and thank those individuals and families who have committed to Good Shepherd's ministries and vision by remembering the Endowment Fund in their estate plans through a documented planned gift. Rod & Staff Society members are: Shirl Ahrens, Laurel Banta, Deborah Bouvier, Robert Brook, Sharon DeVore, Joanne and Doug Forsythe, Lela Highsmith, Miguel Solari, Judy Warner, Andrea Zahn, Carolyn Hughes, and Cheryl & Brian Sharpe.
- 2. The Board has worked diligently in a collaborative effort with the Finance Committee and the Vestry to educate and implement the Investment Policy Statement for the Endowment Fund of the Church of the Good Shepherd., particularly the spending policy limitations.
- 3. ProVise Management Group, LLC (Clearwater, FL) has managed the Fund for the past thirteen years. The Board maintains close communication through emails, monthly and quarterly statements as well as personal presentations by ProVise advisors at our board meetings.
- 4. The Board retains the accounting firm of Tax Solutions Plus to provide the record keeping in accordance with the Diocesan stated requirements. The firm maintains the books and records, prepares quarterly and annual financial statements and associated notes in accordance with the Statements on Standards for Accounting and Review Services established by the American Institute of Certified Public Accountants.
- 5. The annual internal audit, in accordance with Diocesan guidelines, was completed successfully with no recommendation of improvement.

#### Goals

- 1. Continue to monitor with the Vestry the fiscal policies of the Church while adhering to the spending policy articulated in the revised IPS. Our goal is to help educate the Vestry and work cooperatively with them in an effort to continue to lessen the planned dependency on the Endowment Fund for the operations of the Church. The board's investment policy statement uses the fund's valuation date as of October 31, and is based on a rolling 3 year average beginning 2019. This allows for more time to budget for the following year knowing what the maximum disbursement from the endowment could be. A 4% maximum disbursement each year is in line with national endowment fund standards today.
- 2. Continue to review investment results and performance with the investment management team on a periodic basis, at least semi-annually, and to ensure that all adhere to the approved long- term Investment Policy of the Fund and adhere to the (F)UPMIFA.
- 3. Continue to educate and counsel parishioners about the purpose of the Endowment Fund and about vehicles available to make contributions to the Fund that are often tax-beneficial to contributors. Gifts of appreciated securities or other appreciated assets, 401(k) or IRA accounts, and Life Insurance Policies can all be gifted (totally or as a percentage) directly to the Endowment Fund with tax benefits. A particular percentage of an estate or a dollar amount may be gifted to the Endowment Fund in one's will or trust. Board members will be able to assist with information. You may wish to consult with your estate planning attorney given recent tax law changes.

4. To thank and recognize our Rod & Staff Society members annually on Good Shepherd Sunday each year and to encourage others to leave legacy gifts to the Endowment Fund.

#### Investment Results for 2023

The approximate net market value of the Fund on December 31, 2023 was \$1,879,031. This reflects an increase in market value of approx. \$238,000 after disbursements to the church. The Fund's investment performance (time weighted), net of fees and expenses was an increase of 14.06%.

Investment income was approximately \$62,700 during the year. Other income for 2023 included \$500 from the Furniture Thrift Store.

Disbursements to the Church for the year 2023 included \$109,000 requested by the vestry for operating expense shortfall, and contributions to the Rectory improvement project.

Trustee management fees totaled \$10,700 while accounting fees totaled \$1,525.

Other expenses during the year were \$61 for licenses and permits.

Annual net income for the Fund in 2024 is estimated at \$47,000. At December 31, 2023 the asset allocation of the investment portfolio was approximately 63% domestic equities, 10% international equities and 27% fixed income securities and/or cash equivalents.

Good Shepherd is the church it is today, in large part, due to the foresight and generosity of donors who have made planned gifts. Remembering the Endowment Fund in your will/trust is the most enduring statement you can make about your belief in our Christian mission.
