According to Diocesan Canon VII, to be in "good standing," a person must be an enrolled member of the parish, regularly attend divine services, and make stated contributions of record to the general support of the Congregation.
- "Stated contributions of record" means that the person has contributed financially to the congregation in a manner that permits the contribution to be tracked in our financial records.

### EXPECTATIONS OF ENDOWMENT FUND BOARD MEMBERS:

- Worship, Events and Activities Members will be regular in attendance at Good Shepherd's worship services and will actively engage in the fellowship, service events, and activities of the congregation.
- Officer positions: As a small Board, most members will need to fill one of the corporate officer positions mandated by Florida corporation law.
- Board Meetings Members will attend all Board gatherings, in person or remotely.
- Investment Policy, Bylaws and Procedures: Members must agree to and will abide by the policies, bylaws and procedures duly adopted by the Endowment Fund Board.
- Rod & Staff Society Members are strongly encouraged to be or become members of the Rod & Staff Society.
